## **Privacy statement**

This is the privacy statement of A H Worth and Company Limited (“AHW”) which applies to the goods and services offered by AHW including its websites and any AHW Group, affiliate or subsidiary (as the Data Controller) and website that has a link to this privacy statement.

This privacy statement describes how AHW may collect, use and share information from or about you and explains how the information may be used. By visiting AHW Group company websites or engaging in business with AHW Group companies you are accepting and consenting to the practices described below.

## **Information we may collect and use**

## How we share your data

In order to deliver our goods and services we may share information as required or as permitted by law with:

- Companies within the AHW group (including any company which is a subsidiary of our holding company);
- Companies who help us provide goods and or services you have requested to you;
- Our professional and legal advisers, including our auditors;
- Government bodies and agencies e.g. HMRC.

We do not share your information for marketing purposes with any other companies.

We do not transfer personal information to other countries outside of the European Economic Area. In the event this were required we would be responsible for making sure that your information continues to be protected.

## How long will we hold personal information?

We will only hold your personal information for as long as we hold a relationship with you other than for statutory, legal and regulatory purposes where prescribed minimum retention periods exist.
